Good morning Tyler, our building at 11550 Stillwater Blvd North Lake Elmo received an extension for our septic until December 29th, 2023 from the county. The building is owned by individual unit owners, mostly small businesses, in an association. We are currently in the process and will hook up to the Lake Elmo newly instructed water and sewer and we expect to hook up next summer in 2024. Therefore we are requesting an extension until the end of 2024 for this, but we expect completion next June through September.

Our delays have been caused by completing the application with the Mac and getting their determination on cost. We originally submitted the application for the entire building and they "kicked it back" and they want diagrams for each unit separately to identify where all the water connections are. This is a sizable ask. We will need to hire someone to do this design work to communicate written details and maps for this determination.

The current use of the septic, I estimate is between 10% and 15% of what it was at the time the building was at a normal capacity. Since covid, most businesses in our building use the building as a hub and have their employees working from home. For example, Thrivent, who I purchased their unit from several years ago had 15 employees and all their clients, now there are just 3 solo business owners with no clients using the space. This space, alone is at about 10% of the volume use it once was. Most other units have similar statistics.

Because the Mac wants more details prior to their determination, we are happy to provide them this, but it will take us time to hire a professional that can come in and make measurements and designs for this purpose. As small business owners, we are not proficient to do this work ourselves to complete the application.

We have moved forward and we have our estimates for our contractors for hookup so we are prepared to hook up once we get our approval of costs from the Mac. For small business owners this is a sizeable installation.

Please approve this request for the reasons stated.
