The tank was at normal operating level, then was pumped through the maintenance hole for the inspection. Lowered a camera into the empty tank - bottom, walls, cover, baffles, riser and maintenance hole cover ok.

Although not a compliance component, it should be noted that the maintenance hole cover has minor chipping around the edges and the deck support post appears to be located over the septic tank.

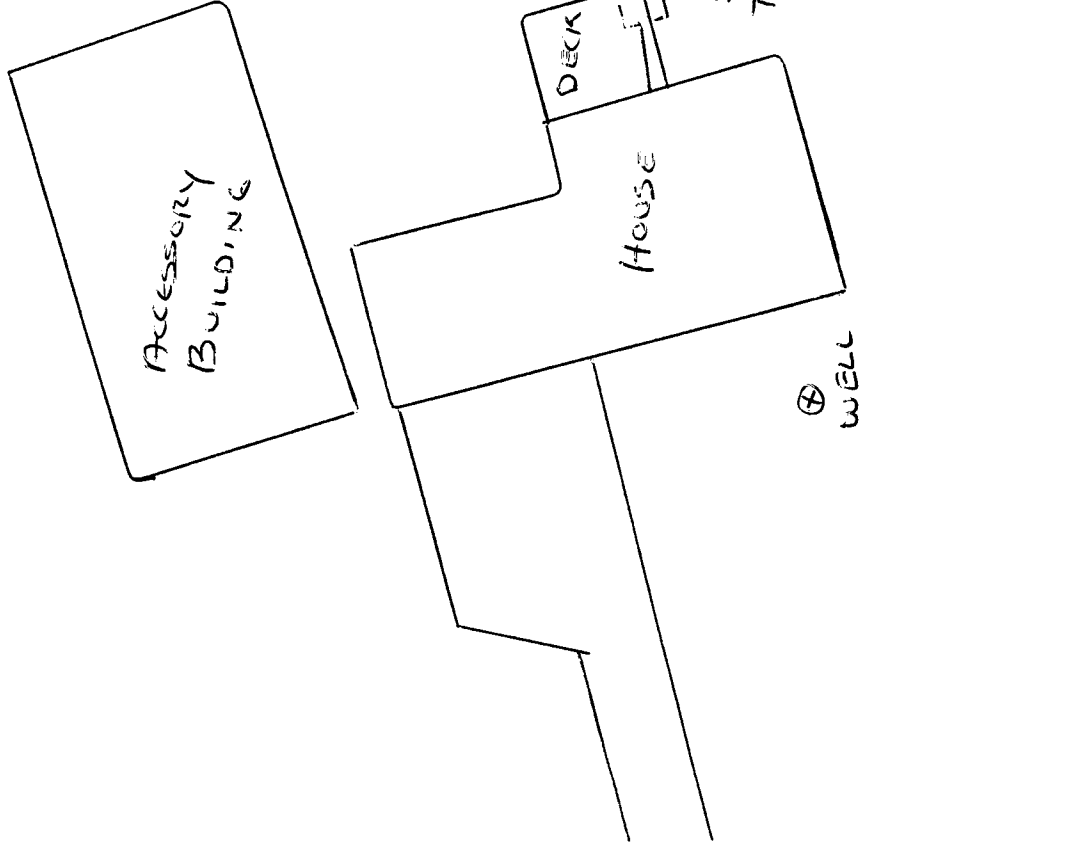
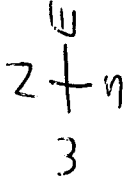

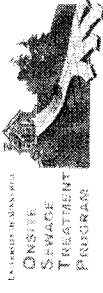
